3. Subject to the provisions of the Companies Act, 2013 to amalgamate with any other Company having objects altogether or in part similar to those of this Company registers and branch places of the main business in any part of the world.

10. 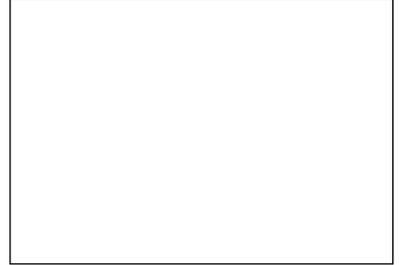
